PhD COURSE WORK DETAILS

(Applicable to all Courses/ Degrees based on research)

This REGULATION is to be read with the relevant Direction governing PhD Registration in various faculties of the GONDWANA UNIVERSITY, GADCHIROLI.)

1.0 INTRODUCTION

The students registered as PhD Scholars in this University, in accordance with the provisions of governing Direction/ Ordinance shall be required to successfully complete their Course Work, as has been made mandatory by the University Grant Commission vide its Clause No. 13 of UGC Regulations, 2009, published in the Gazette of India, dated 11th July, 2009. The Course Work shall be called as 'PhD Course Work' (PCW). As per governing provisions, no candidate shall be allowed to submit his/ her thesis without PCW Completion Certificate and Consolidated Memo of Marks (CMM) by this University.

2.0 DURATION

As directed in the aforesaid UGC Regulation, the PCW shall be of six months (one semester) duration, comprising of 60 hours of teaching. In all, there will be 12 credits attached to this Course.

3.0 EXEMPTION FROM COURSE WORK

- (3.1) The Candidates who have completed their PhD either from this University or any other University recognized by the UGC from time to time shall be exempted from passing PCW examination to the extent of Papers I and II only.
- (3.2) The Course shall be mandatory for all the students pursuing PhD/ M. Phil/ M.E. (By Research) from this University, except exempted under above paragraph.
- (3.3) The Candidate seeking exemption in any paper(s) shall submit application in prescribed format along with the relevant documents to the A.R. (PhD Cell). All the documents MUST be self attested by the Candidate himself/ herself.
- (3.4) The A.R. (PhD Cell) shall put the cases of Candidates seeking exemption before the Course Coordination Committee (CCC) for its consideration and approval. The decision of the CCC shall be final and binding on all.
- (3.5) The Consolidated memo of Marks will show equivalent marks, granted by the CCC, in the Paper(s) in which the exemptions are granted by the University, with award of respective credits. These marks in Paper I and II shall be generated as per equivalence scheme approved by the University and the marks secured by the candidate in Paper III and IV shall be basis for that. However, it is to be noted that as the Paper III and Paper IV are specific research topic related Papers; all the candidates have to clear these papers.

4.0 CONDUCT OF PhD COURSE WORK

- Research' and the PhD Supervisors shall inform their respective PhD Scholars to apply for admission/ registration into the PhD Course Work. The students shall be entertained for admission only after they have letter from the PhD Cell of the University regarding grant of PhD registration to them by the University. A Teacher from the University Department/ Conducted College/ Affiliated College not below the designation of Associate Professor shall be appointed by the Hon'ble Vice Chancellor as the Course Coordinator, by issuing a Notification. The Vice Chancellor shall appoint two other Teachers as the Members in the Course Coordination Committee (CCC), in consultation with the Course Coordinator. The CCC shall chalk out entire semester program, in respect of :
 - Admission to the Program (to be displayed on website)
 - Display of Admitted students list on the website
 - Display of Time Table for conduct of PCW
 - Arrangement of Resource Faculty for conduct of Program
 - Identification of Hall for conduct of Course Classes with necessary teaching aides
 - Attendance Monitoring
- 4.2 The Students shall be allotted with ADMISSION CODE NUMBER. The students having not less than 75% of attendance in the course work classes only shall be allowed to appear for the examinations. Attendance certificate shall be issued by the Course Coordinator to the concerned candidates.
- 4.3 The Controller of Examinations shall prepare & display examination time table, conduct of examinations, execute valuation of answer books and declare results, in consultation with the CCC. After receipt of Internal Assessment marks from the respective research centre Consolidated Memo of Marks (CMM) shall be issued by the University.
- 4.4 The Principal/ Director of the concerned rsearch centre shall be responsible for the completion of course work and assessment of Paper III and IV, as mentioned in the scheme of examinations. This evaluation shall be carried out by the concerned Supervisor/ Co-Supervisor. The fee prescribed and fixed from time to time by the University shall be charged by the research centre towards conduct/ assessment of Paper III and IV or may be adjusted in their Term Fee itself.
- 4.5 The candidate shall fill up the examination form along with the prescribed examination fee through their research centre. The concerned Principal/ Director shall submit the examination forms along with the prescribed fee to the University, as per notified schedule.

- 4.6 The PCW shall comprise of TWO parts. The first part shall consist of two papers (Paper I and II) for which the examination shall be conducted by the University and the assessment also shall be carried out by the University. The second part also shall consist of two papers (paper III and IV) for which the necessary preliminary part and assessment shall be carried out at the level of respective research centre.
- **4.7** The list of Candidates admitted to the PCW Program shall be prepared & displayed by the A. R. (PhD Cell), after expiry of the last date of admission and approval from the CCC.
- 4.8 The Intake to the PCW program shall be limited to fifty only. The CCC shall have discretion increase the number of batches, if required.

5.0 SCHEME OF TEACHING & EXAMINATIONS

5.1 The scheme of teaching and examinations is mentioned below and is self explanatory

- 5.2 Paper III and IV shall be supervised & evaluated by the concerned Supervisor/ Co-Supervisor at the respective research centre only. In Paper III, the philosophy behind the proposed work, hypothesis and research methods to be adopted in the work shall be studied. Various academic activities like preliminary field visit / site visit/ industry visit may be taken and comprehensive report shall be submitted by the candidate. However, the Paper IV shall concentrate on exhaustive survey of literature in the specific domain area and preparation of a Review Paper. A seminar also shall be delivered by the candidate on Paper IV work.
- 5.3 The Marks so obtained in Paper III and IV shall be submitted to the A. R. (Confidential), in softcopy as well as hardcopy, in the prescribed format only.
- 5.4 The examinations for the Papers I and II shall be conducted by the University twice a year, which is in summer and winter session.

- 5.5 The Panel of Examiners shall be recommended by the CCC with the approval of Hon'ble V. C. The question paper for Research Methodology shall be in English & Marathi languages.
- 5.6 The result in Consolidated Memo of Marks (CMM) shall be shown as PASS or FAIL. Only subject wise marks (that too if not exempted) shall be shown in CMM and total marks shall not be printed.
- 5.7 The Candidates shall be allowed to undertake FOUR attempts to clear all the four Papers.
- 5.8 The PCW Admission Form shall be available on University Website. The Candidates can fill & submit it online with the prescribed fee. Else, the PCW Admission Examination Form may be downloaded from the website and duly filled hard copy may be submitted along with the prescribed fee through their respective research centre.
- 5.9 The Examination Form shall be submitted by the Candidates as per schedule & procedure notified by the COE.
- 5.10 The CMM shall be passed on to the Candidates, through their respective research centre.
- 5.11 There will be no revaluation of any answer book.
- **5.12** The PhD Course Work fee and the Examination shall be as notified & fixed from time to time by the University.
- 5.13 The PCW Paper I and II exempted candidates shall be exempted from payment of University prescribed Course fee.
- **5.14** However, all the Candidates shall pay admission and examination fee prescribed by the University, irrespective of the number of exempted Papers.
- The competent Teachers shall be arranged by the University to conduct the classes for Paper I and II.
- **5.16** No Candidate shall be allowed to submit the thesis unless CMM or PhD Course Completion Certificate is attached.
- 5.17 No honorarium shall be paid from the University side to the Supervisors/ Co-Supervisors for their supervision and assessment of Papers III and IV.

- (ii) Reading and taking notes from the important concerned books, research papers and articles and submitting 'CONCEPT NOTE' on the concerned research topic and giving its presentation.
- (iii) Visit to Research Laboratories/ Institutes/ Organizations and submitting its report.
- (iv) Experimental/Laboratory / Field work and submitting its report
- (v) Comprehensive Viva Voce

PAPER - IV : SPECIFIC DOMAIN RESEARCH & SEMINAR (CODE – RS)

MAX MARKS : 100 CREDITS : 04

The following points shall be considered while assessment of this paper

- (i) Attending at least TWO Seminars/ Conferences of International/ National level and submission of Certificates,
- (ii) Presentation of Poster or Abstract in Seminar/ Conference (Submit Certificate)
- (iii) Attending TWO Workshops (Submit Certificates)
- (iv) Training in Research Laboratory/ Organization for not less than TWO WEEKS and give viva voce (Submit Certificate)
- (v) FOUR Seminars (preferably half yearly) on 'progress of research work' which will be attended by 'Expert from External Organization/ Institution' to be appointed by the Head of the Institution and submission of its report singed by the concerned persons.
- (vi) Preparing Research Papers (minimum two) for publication on the research work and their publication in the refereed / indexed Journal of International/ National level with impact factor not less than 0.5. However, a Candidate acquiring International/ National Patent shall be exempted from the research paper publications.
 - It is to be noted that conditions mentioned above in (v) and (vi) are mandatory. However, the students have to fulfill any TWO from the first four conditions.
 - The duration of completion for this paper shall be minimum two years.
 - The Head of the Institution shall submit the marks in consultation with the concerned Supervisor/ Head of the Department/ research Head at the research centre level. The Head shall judiciously ensure all necessary steps to maintain high quality of research at his/ her research centre.

7.0 QUESTION PAPER PATTERN

The Candidates shall be assessed in Paper I and II on the basis of Marks obtained by them in the question papers for which the examinations shall be conducted by the University. The candidates shall have to score minimum 50% of the maximum marks to pass a paper. The Paper pattern and other details are mentioned below:
